

## SYNOPSIS OF BOARD OF GOVERNORS

### MARK ALKERSTONE

Mark is Practice Director at AWW Architects and manages a busy practice covering national projects across 3 offices. At present the School has around two hundred full fee bursary places, and has the aim eventually to become completely needs blind. Prior to taking up the post at MGS Dr Boulton was the Under Master at Westminster School in London. He trained initially as an engineer and prior to joining the teaching profession he worked in the mining industry and then Arthur Andersen.
